Dave Albers presented the 2023 profit & loss statement, balance sheet and 2024 budget. Barb Rolston asked about the insurance price, thinking that it was low. Dugger said that it is only liability and it is fine. Dugger brought up late fees and they agreed on \$20 after giving people a warning.

Members and the BOD discussed the following community items on the agenda in open discussion.

- 1. Concrete The list from Paula is complete, but we may still have some repairs in the future. It will have to be enough that a concrete company would take the time to bid on it.
- 2. Weeds The lawn company needs to do a better job removing the weeds in the rocky areas.
- 3. Trees We need to replace at least four trees that have died. Bryan will walk around to identify them and work with Albers to get them replaced.
- 4. 3635 O'Sullivan has a tree in the commons on the Yankee Hill side, that needs cleaned up.
- 5. Sprinkler zone map can be put up on the website.
- 6. Gutters The mowers still need to do a better job picking up the gutter extensions and replacing them when mowing. Bryan suggested vinyl downspouts that roll up when not in
- 7. Dave Wilder asked what the rules are for truck or trailers parked in driveways or on the streets. When notified, the property manager can put out parking violation notices for vehicles to be towed at the owner's expense if they are not moved by the notice's specified date. - 8. Julie Adams asked if anyone in SH is experiencing an increase in insurance. Theirs was raised 30 35%.
